Q3 2011 saw a new record in company registrations in Halifax when compared to any previous Q3.


Q3 2011 was a record quarter for company registrations in Halifax when compared to any quarter in history.

new companies by quarter










net growth by quarter







The percentage of directors over the age of 65 was 6.3% compared to the UK figure of 4.1%.


director age by quarter
