Q1 2011 saw a new record in company registrations in Rotherham when compared to any previous Q1.


Q1 2011 was a record quarter for company registrations in Rotherham when compared to any quarter in history.

A total of 219 companies were registered in Rotherham during the first quarter of 2011 (Jan 2011 - Mar 2011).

This figure is an increase of 32.7% versus the same period last year (Q1 2010). This figure compares well to the UK as a whole, which saw an increase of 10.7% against the same period last year.





dissolved companies by month









company share by month





The percentage of directors over the age of 65 was 4.7% compared to the UK figure of 4.3%.


#### director age by quarter
