The first half of 2012 saw a new record in company registrations in Wrexham when compared to any previous first half year.


The first half of 2012 was a record first half year for company registrations in Wrexham when compared to any half year in history.

In the first half of 2012 a total of 245 companies were formed in Wrexham. This figure is 7.9% higher than last year, which compares equally to the UK wide figure of 10.7%.

The highest total for a first half year in Wrexham occurred in 2012 when a total of 245 were formed.

new companies by half year




Quarterly Data (Q2 Apr-Jun 2012)





dissolved companies by half year




Quarterly Data (Q2 Apr-Jun 2012)



dissolved companies by month



net growth by half year









company share by half year







director age by half year






director age by quarter

director gender by half year


